12. For the purposes of your application for the post of a MCI volunteer it is our policy to ask for a check to be carried out by AccessNI, and where applicable a GARDA vetting check.

The purpose of the AccessNI/ GARDA check is to make sure that people are not appointed who might be a risk to vulnerable people. The Check will tell us whether you have a criminal record, or whether the DHSS& PS holds any other information about you, which might have a bearing on your suitability. All information that we receive will be treated confidentially, and will be discussed with you before we make a final decision. After that decision is made the information will be destroyed.

I understand that an AccessNI/GARDA check must be carried out before my application for registration/appointment can be confirmed. This has been explained to me and I am aware that spent convictions may be disclosed.

I declare that the information I have given is accurate and I consent to the check being made. I declare that the above information is true and agree that I will abide and accept the terms and conditions of membership / participation.
